technical requirements aim to help protect the environment. In addition to being
compliant with Viatris global EHS management system, policies and principles, many of
our production facilities are certified to ISO 14001 (environmental management) and ISO
50001 (energy management), and we are committed to expanding ISO certification to
other locations.
