  providing them with the personal protective equipment and knowledge required to perform
  their jobs safely. Further, we work to ensure that our systems and processes are designed to
  identify and reduce health or safety risks or impacts on the communities in which we operate.
- Viatris is committed to providing transparent information and we report regularly on our progress. We measure and report on our health and safety performance at least annually; information is presented on our website and in company reports.

## **Comply with All Applicable Health and Safety Regulations**

 We work to ensure compliance with all applicable health and safety regulations in all countries in which Viatris operates. Where laws and regulations do not provide adequate controls, our own technical requirements aim to protect human health and safety. We stipulate that contractors, vendors, and visitors adhere to regulatory requirements and meet Viatris' health and safety technical requirements.

#### **Continually Monitor and Improve Safety Performance**

- We set objectives and targets, monitor safety performance, and strive to continually improve
  health and safety within our operations by implementing practices consistent with the
  principles, programs, and technical requirements in our EHS management system, including
  periodic audits to evaluate our health and safety
  performance.
- Regular engagement with key stakeholders and transparency regarding Viatris health and safety
  performance are key to our ability to continuously improve our health and safety performance.
   We foster openness and dialogue on EHS matters with key stakeholders, both internal and
  external, communicating risk, performance, and progress.



## **Prevention of Injuries and Incidents**

We conduct risk assessments and prioritize our resources to eliminate or reduce risk through
risk mitigation efforts. We address workplace risks that could lead to severe injuries or
fatalities, and we follow the hierarchy of controls, seeking elimination of the risk, substitution,
or engineering controls over administrative controls and personal protective equipment when
feasible.

## **Proactively Protect Colleagues, Contractors, and Other Stakeholders**

- We provide a safe and healthy workplace through comprehensive health and safety
  management systems, planning, risk assessments, and hazard identification education. Our
  risk assessment program enables us to understand potential risks to colleague health and
  safety so that we can proactively manage those risks and protect our employees, contractors,
  and other stakeholders.
- Our hazard identification program emphasizes through training and communication that all
  incidents are preventable and empowers everyone to protect themselves and their colleagues
  by identifying and reporting hazards before they cause an incident.
- Across all locations, we are committed to protecting contractors and visitors. They are covered
  by site-specific EHS policies and procedures, and we track the safety performance of our
  contractors through established guidelines, pre-screening, and training.

## **Promote Personal Responsibility Through Training**

Through training and communication, we promote and maintain a work environment in
which everyone is responsible for their own safety and that of their colleagues. Regardless
of whether someone is a contractor or full-time employee, we train and empower everyone
to speak up and take action to prevent an incident from occurring. Our training program
ensures that all colleagues, contractors, and other stakeholders are equipped with the
knowledge they need to stay safe while carrying out our mission.

## **Collaborate with Suppliers**

 As a member of the Pharmaceutical Supply Chain Initiative, we engage and work with our sector and suppliers to convey our expectations and share good practices to partner in the continuous work of improving health and safety performance. We work with suppliers and other business partners to embed health and safety expectations in our supplier engagement wherever possible.
